NOW THEREFORE THE CITY OF GRAND RIVERS, KENTUCKY DOES ORDAIN

SECTION 1. All parts of the streets as follows:

The part of Suwanne Avenue beginning at the northeast corner of lot #29 & (J.H. O'Bryan Ave) continuing to the northwest corner of lot #30 & (12^{th} Street) joined on the north side by the old hotel site as shown on the official Grand Rivers city plat a distance of 100 fact + or - X a width of 60 feet according to the official city plat of the City of Grand Rivers, Kentucky.

All alleys that run parallel and perpendicular to each street as listed herein are included in this ordinance.
