AN ORDINANCE ADOPTING THE ANNUAL OPERATING BUDGET FOR FISCAL YEAR  
BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024

WHEREAS, the City of Grand Rivers desires to adopt its annual operating budget, and

WHEREAS, the City of Grand Rivers has reviewed and discussed the proposed budget and desires to adopt it for the upcoming fiscal year,

**NOW THEREFORE BE IT ORDAINED BY THE CITY OF GRAND RIVERS, KENTUCKY AS FOLLOWS:**
