SECTION 4: RESPONSIBLE PARTY

SECTION 5:GENERAL REQUIREMENTS

SECTION 6:MAXIMUM OCCUPANCY

SECTION 7:MINIMUM OCCUPANCY

No short-term rental shall be for a period of less than twenty-four (24) hours

SECTION 8: PAYMENT OF TAXES REQUIRED

- If applicable, all hosts shall obtain a city occupational license prior to listing his, her, of its

 If applicable, all hosts shall be responsible for payment of all transient room taxes and
- 0 occupational license taxes.

 All hosts are ultimately responsible for the remittance of applicable taxes associated with short term rentals within the City of Grand Rivers, including (but not limited to), sales tax.

SECTION 9: COMPLAINTS

property: The following regulations shall apply to the administration of complaints related to the short-term rental

Upon the filing of a complaint regarding the short-term rental unit, the City shall notify the registrant of such complaints.



- $\overline{\mathbb{B}}$ If the City determines that violation of this section or any other ordinance or law relating to the short-term rental has occurred, the right to operate the short-term rental may be revoked by the City Clerk. Before any revocation action is taken, the City Clerk shall give the real property owner fifteen (15) days written notice of the alleged violations and an opportunity to respond.
- 0 the mayor. The real property owner may appeal the revocation of the short-term rental registration to The mayor shall reduce his or her decision in writing

SECTION 10:PENALTY

- 3 Any person who violates any provision of this chapter shall be subject to a civil penalty of one hundred dollars (\$100.00) per day for each day the property is in violation of the Ordinance. Each day of violation constitutes a separate offence. The City shall possess a lien on property for all civil fines, penalties, charges, past-due amount, fees, attorney fees, and all other reasonable costs associated with
