BUDGET AMENDMENT ORDINANCE

AN ORDINANCE AMENDING ORDINANCE 02-2015, THE ANNUAL BUDGET AND APPROPRIATIONS FOR THE FISCAL YEAR JULY 1, 2015 THROUGH JUNE 30, 2016 FOR THE CITY OF GRAND RIVERS, KENTUCKY.
