

ORDINANCE 02-2017

AN ORDINANCE RELATING TO THE ANNUAL BUDGET AND APPROPRIATIONS FOR THE FISCAL YEAR JULY 1, 2017 THROUGH JUNE 30, 2018 FOR THE CITY OF GRAND RIVERS, KENTUCKY.

WHEREAS, a public hearing was held on the proposed budget at 5:30 pm on the 13th day of June 2017 and,

WHEREAS, the City must provide revenue to fund operations of the city and,

WHEREAS, the City must impose guidelines for expenditures of revenue sources and,

WHEREAS, the City's budget proposal was presented to the legislative body and,

WHEREAS, the City by this ordinance does make appropriations for funding City Government operations for the forthcoming fiscal year:

NOW THEREFORE BE IT ORDAINED BY THE CITY OF GRAND RIVERS:
