

ORDINANCE 03-2008

AN ORDINANCE RELATING TO THE ANNUAL BUDGET AND  
APPROPRIATIONS FOR THE FISCAL YEAR JULY 1, 2008 THROUGH JUNE  
30, 2009 FOR THE CITY OF GRAND RIVERS, KENTUCKY.

WHEREAS; a public hearing was held on the proposed budget on the 17th day of June  
2008 and,

WHEREAS; the City must provide revenue to fund operations of the city and,

WHEREAS; the City must impose guidelines for expenditures of revenue sources and,

WHEREAS; the City's budget proposal was presented to the legislative body and,

WHEREAS; the City by this ordinance does make appropriations for funding City  
Government operations for the forthcoming fiscal year:
