

ORDINANCE NO 03-2018

GOLF CART ORDINANCE AMENDMENT

AN ORDINANCE AMENDING ORDINANCE 02-2010 AUTHORIZING THE USE OF GOLF CARTS ON CERTAIN DESIGNATED CITY STREETS

WHEREAS, KRS 189.286 was enacted by the Kentucky General Assembly which authorizes the use of golf carts on certain city streets;

WHEREAS, The City of Grand Rivers, Kentucky adopted Ordinance 02-2010 authorizing the use of Golf Carts on certain city streets; and

WHEREAS, the City Council deems it appropriate and necessary to amend the provisions of Ordinance 02-2010;

NOW THEREFORE THE CITY COUNCIL OF GRAND RIVERS, KENTUCKY DOES ORDAIN:

CITY OF GRAND RIVERS ORDINANCE 02-2010 IS HEREBY AMENDED AS FOLLOWS:

SECTION 3. Operation Requirements

In order to be operated on such designated city streets, a golf cart shall:

- (1) Be issued an annual permit for the golf cart by the City. Annual permits shall be issued by the Grand Rivers City Clerk at a fee of \$20.00 per year;
- (2) Display a sticker or permit that identifies that the golf cart is allowed to be operated on specific roadways within the City; and
- (3) Be inspected by a certified inspector designated by the Livingston County Sheriff's office and certified through the Department of Vehicle Regulation to ensure that the golf cart complies with the requirements of this section. The inspection fee under this paragraph shall be twenty dollars (\$20). Inspections shall occur at Grand Rivers City Hall.
- (4) Display a slow-moving vehicle emblem in compliance with KRS 189.820;
- (5) Be insured in compliance with KRS 304.39-080 by the owner or operator, and the proof of insurance shall be inside the golf cart at all times of operation on a public roadway.
- (6) Be operated only between sunrise and sunset;
- (7) Be operated by a person with a valid operator's license in his or her possession;
- (8) Display a safety flag which extends not less than seven (7) feet above ground, be dayglow in color, be triangular in shape with an area of not less than thirty (30) square inches.
- (9) Be outfitted with headlights and tail lights to be operated at all times.

This ordinance shall be read on two (2) separate days and will become effective upon publication of title and certified summary thereof.
