NOW THEREFORE THE CITY COUNCIL OF GRAND RIVERS, ORDAIN: KENTUCKY DOES

SECTION 3. Operation Requirements

In order to be operated on such designated city streets, a golf cart shall:

- (1) Be issued an annual permit for the golf cart by the City. Annual perm shall be issued by the Grand Rivers City Clerk at a fee of \$20.00 per year; Annual permits
- operated on specific roadways within the City; and (2) Display a sticker or permit that identifies that the golf cart is allowed to be
- (3) Be inspected by a certified inspector designated by the Livingston County Sheriff's office and certified through the Department of Vehicle Regulation to ensure that the golf cart complies with the requirements of this section. The inspection fce under this paragraph shall be twenty dollars (\$20). Inspections shall occur at Grand Rivers City Hall.
- (4) Display a slow-moving vehicle emblem in compliance with KRS 189.820;
- a public roadway. and the proof of insurance shall be inside the golf cart at all times of operation on (5) Be insured in compliance with KRS 304.39-080 by the owner or operator,
- (6) Be operated only between sunrise and sunset;
- possession; (7) Be operated by a person with a valid operator's license Ξ, his 2 her
- (8) Display a safety flag which extends not less than seven (7) feet above ground, (30) square inches. be dayglow in color, be triangular in shape with an area of not less than thirty
- (9) Be outfitted with headlights and tail lights to be operated at all times
