

ORDINANCE NO 04 - 2016

AN ORDINANCE AMENDING ORDINANCE 05-2006 AUTHORIZING AND APPROVING
A NEW SCHEDULE OF CONNECTION FEES FOR COMMERCIAL CONNECTIONS ONTO
THE CITY OF GRAND RIVERS WATER MAINS

WHEREAS, the City of Grand Rivers desires to maintain an effective and efficient water system,
and

WHEREAS, the City of Grand Rivers has incurred rising costs and expenses associated with
maintenance and renovation of the City's water system, and

WHEREAS, the City of Grand Rivers needs to increase and update its water tap on fee schedule
for connection to the City water mains.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF GRAND RIVERS,
KENTUCKY AS FOLLOWS:

SECTION 1. Fee Schedule: The fee schedule as set forth in Section 1 of City of Grand Rivers
Ordinance 05-2006 is hereby amended to include additional information within Section 1 as
follows:

All connections for commercial users, regardless of size, shall be priced at
COST PLUS 20%.

SECTION 2: Severability: Any clause, provision, paragraph, section of the ordinance that may
be ruled void or unenforceable of any competent jurisdiction, the remainder thereof is intended to
be enacted and shall be in full force and effect notwithstanding.

SECTION 3: All Former provisions in conflict repealed: All ordinances, orders, resolutions,
motions or parts thereof insofar as some may be in conflict herewith are repealed.

SECTION 4: Effective Date: This ordinance shall take effect upon publication.
