The office of City Administrative Officer shall have a salary of \$42,000 and not to exceed \$50,000 per year. The office of Utility Manager shall have a salary of \$45,000 and not to exceed \$55,000 \$65,000 per year. The office of City Clerk shall have a yearly salary of \$25,000 and not to exceed \$45,000 \$50,000 per year.
