

**ORDINANCE NO. 04-2021**

**COMPENSATION OF NON-ELECTED CITY OFFICERS**

AN ORDINANCE AMENDING ORDINANCE 04-2020 RELATING TO COMPENSATION FOR NON-ELECTED CITY OFFICERS

**WHEREAS**, the City Council of the City of Grand Rivers, Kentucky recognizes it is in the best interest of the City to provide fair and competitive compensation to non-elected city officers; and

**WHEREAS**, the City Council of the City of Grand Rivers, Kentucky set forth a compensation schedule for non-elected city officers in Ordinance 04-2020; and

**WHEREAS**, the City Council of the City of Grand Rivers, Kentucky recognizes the need to amend the City's compensation schedule for non-elected city officers;

**NOW THEREFORE THE CITY COUNCIL OF GRAND RIVERS, KENTUCKY DOES ORDAIN:**

**SECTION 1.** Ordinance 04-2020 Section 1 is amended as follows:

The office of City Administrative Officer shall have a salary of \$42,000 and not to exceed \$50,000 per year. The office of Utility Manager shall have a salary of \$45,000 and not to exceed ~~\$55,000~~ \$65,000 per year. The office of City Clerk shall have a yearly salary of \$25,000 and not to exceed ~~\$45,000~~ \$50,000 per year.

**SECTION 2.** Severability.

If any section, paragraph, sentence, clause, or provision of this Ordinance shall be held invalid, the invalidity of the same shall not effect any of the remaining provisions of this Ordinance.

**SECTION 3.** Ordinances in Conflict Repealed.

All Ordinances, resolutions, orders, or parts thereof in conflict with the provisions of this Ordinance, but only to the extent of such conflict, are hereby repealed.

**SECTION 4.** Enactment.

This ordinance shall be read on two (2) separate days and will become effective upon publication of title and certified summary thereof.
