

ORDINANCE 05-2006

AN ORDINANCE AMENDING ORDINANCE DATED APRIL 11, 1989 AND (ORDINANCE 05-96 SECTION 4, DATED AUGUST 13, 1996) AUTHORIZING AND APPROVING A SCHEDULE OF CONNECTION FEES FOR CONNECTION ONTO THE CITY OF GRAND RIVERS KENTUCKY WATER AND SEWER MAINS

WHEREAS: The cost of labor, equipment, and materials have increased significantly since 1989, and

WHEREAS: The City needs to increase and update its water and wastewater tap on fee schedule for connection to the City water and wastewater mains.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND RIVERS, KENTUCKY.

SECTION 1. That the fee to connect (Tap On) to the water system mains of the City of Grand Rivers shall be amended as follows:

5.) 2"	\$900.00	<u>COST PLUS 20%</u>
6.) 4"	\$1250.00	<u>COST PLUS 20%</u>
7.) 7"	\$1850.00	<u>COST PLUS 20%</u>

SECTION 2. That the fee to connect onto the wastewater system of the City of Grand Rivers shall be amended as follows:

SECTION 3. This Amendment to The Ordinance dated April 11, 1989 and Ordinance 05-96 dated August 13, 1996 Shall be read on two, (2) Separate days and become effective upon its passage, approval and publication as required by law.
