NOW THEREFORE THE CITY COUNCIL OF GRAND RIVERS, KENTUCKY DOES ORDAIN:

FOLLOWS: CITY OF GRAND RIVERS ORDINANCE 05-2005 SI HEREBY AMENDED AS

SECTION 1. DEFINITIONS

INOPERATIVE CONDITION. Unable to move under its own power due to defective or missing parts, and which has remained in such condition for a period of not less than ten consecutive days. A motor vehicle shall be presumed to be in an inoperative condition if any required registration for the vehicle is not in full force and effect for greater than thirty (30) days.

SECTION 3. CERTAIN CONDITIONS DECLARED A NUISANCE

Accumulation of brush. which can be seen or observed from the roadway. General prohibition of noise. not limited to, tree limbs, allow to be made The accumulation or storage of brush, including It shall be unlawful for any person to make, bushes, or any other vegetative substance or continued any noise disturbance.

allow to be made offensive or unsanitary odors. It shall be unlawful for any person, firm, or corporation to cause or

SECTION 4. ABATEMENT PROCEDURE.

Whenever a nuisance situation is discovered, the authorized city official shall give five to thirty days written notice to remedy the nuisance situation.

This ordinance shall be read on two (2) separate days and will become effective upon publication of title and certified summary thereof.
