AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET FOR FISCAL YEAR
BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025

WHEREAS, the City of Grand Rivers adopted its annual operating budget, Ordinance 04-2024,
on June 11, 2024; and

upcoming fiscal year,


