

**ORDINANCE 08-2015**

**BUDGET AMENDMENT ORDINANCE**

**AN ORDINANCE AMENDING ORDINANCE 02-2015, THE ANNUAL BUDGET AND APPROPRIATIONS FOR THE FISCAL YEAR JULY 1, 2015 THROUGH JUNE 30, 2016 FOR THE CITY OF GRAND RIVERS, KENTUCKY.**

WHEREAS; the City of Grand Rivers adopted Ordinance 02-2015 relating to the cities' budget; and

WHEREAS; the City must provide revenue to fund operations of the city; and

WHEREAS; the City must impose guidelines for expenditures of revenue sources; and

WHEREAS; the City must impose guidelines for expenditures of revenue sources; and

WHEREAS; the City's budget must be amended to reflect changes to the revenue and expenditures of the Tourism Commission; and

WHEREAS; the City by this ordinance does amend Ordinance 02-2015 as follows:

**NOW THEREFORE BE IT ORDAINED BY THE CITY OF GRAND RIVERS:**

SECTION 1. The following budget is adopted for the fiscal year beginning July 1, 2015 and ending June 30, 2016 and the amounts stated are appropriated for the purposes as outlined:
